Draft Competition Terms and Conditions:

1. This competition is organized and run by Real People (PTY) Ltd registration number 2001/004440/07.
2. The competition shall run from the 1<sup>st</sup> of November 2011 to the 31<sup>st</sup> of January 2012. All customers who apply for a loan with Real People which is approved during this period shall automatically be entered into the lucky draw and stand a chance to win a Hyundai i10.
3. The prizewinner will be selected by means of a random lucky draw which will take place in Johannesburg on the 17<sup>th</sup> of February 2012 (Friday) at 14:00.
4. The draw will be conducted in the presence of an independent accountant.
5. The competition is limited to one entry per qualifying customer.
6. To qualify for entry the customer must meet the following requirements:
  - 1) He/she must be between the ages of 18 and 65.
  - 2) He/ She must be a South African citizen.
  - 3) He/she must have a valid South African driver's license.
